



Hole-by- Hole Course Risk Assessment - Cover Note

Hagley Golf Club is committed to ensuring it complies with all Health and Safety legislation for the benefit of its employees and all those that use the Club's facilities. This golf course risk assessment is reviewed regularly to reflect course changes and relevant guidance.

In accordance with specific legal guidance received this risk assessment seeks to:

- identify the hazards that exist (including the unsafe conditions from poor weather);
- determine the level of risk those hazards present and who is at risk;
- identify control measures to eliminate or else minimise the risk so far as reasonably practicable.

The risk assessment specifically considers registered disabled golfers who require a buggy to access the golf course and the hazards and risk levels that apply when buggies are in use.

Control measures, such as the use of mandated routes and/or paths, are identified during the risk assessment to create a safe environment for all golfers, including those registered disabled. The control measures are designed to achieve the legitimate aim of health and safety for all employees and golfers. To ensure these comply with equality legislation measures described are proportionate with the potential hazards identified.

The Golf Club has made significant investment in taking reasonably practicable measures and made physical adjustments to the course by installing buggy paths on holes 1 to 9. However, due to the topography it has not been reasonably practicable to install paths on holes 10 to 18. Instead, there is continuing installation on those areas of holes 10-18 where it is practicable. However, this will not offer the extent of coverage available on holes 1-9.

Wherever possible access to the course for registered disabled golfers that require a buggy will be made available on holes 1-9, or 1-5 only.

The Club also reserves the right to restrict the use of electric trollies to those fitted with 'Winter Wheels'. In wet conditions it may be requested that golfers use paths with electric trollies and follow the 90-degree rule. Or to use carry bags, if possible, to minimise damage and reduce risk of accidents.

- Course Topography Considerations & Restrictions

Due to the historic layout of the Hagley Golf Club's course, in particular holes 10-18, consideration has, and continues, to be given to the potentially hazardous nature of this section of the course for electric trollies. Reasonable measures have been taken, and are planned to continue, with paths in

areas that will enable the use of electric trollies safely. However, in extremely wet conditions electric trollies may not be permitted on these holes.

To this effect, after careful consideration and risk assessments having been carried out The Club reserve the right, following golf course assessment by greenkeepers, to restrict course access to golfers using carry bags.

This Is Done Hole To Hole

Hole 1

There are steps leading up to the tee.

From the tee's, there is a buggy path that leads to the left of the fairway.

From the tee's, there are ditches to the left and to the right. The ditch to the left also comes into play from the Second Holes Tee. Players should therefore shout "FORE", to warn players on the second fairway if their tee shot is seemingly going in that direction. There are 2 crossing points to reach the 2nd fairway. When crossing these, please make sure that you cross them with care and attention.

Golf Balls from both ditches should only be retrieved by using an extended ball retriever, as both ditches have steep sides.

In the case of changing weather, the hole is tree lined on both sides, and players should be wary of leaves, branches, that could blow and fall across the hole.

A bunker lies to the right of the fairway and to the left and back right of the green.

A rake is placed in each of the bunkers. Players should place the rake back on its holder with the spikes in the sand.

A fence separating the hole from a road runs full length at the back of the green. Please be careful when retrieving your ball from this area.

Players should wear appropriate footwear as ground could be slippery in wet weather.

Buggy advice for 1st hole (including access for registered disabled)

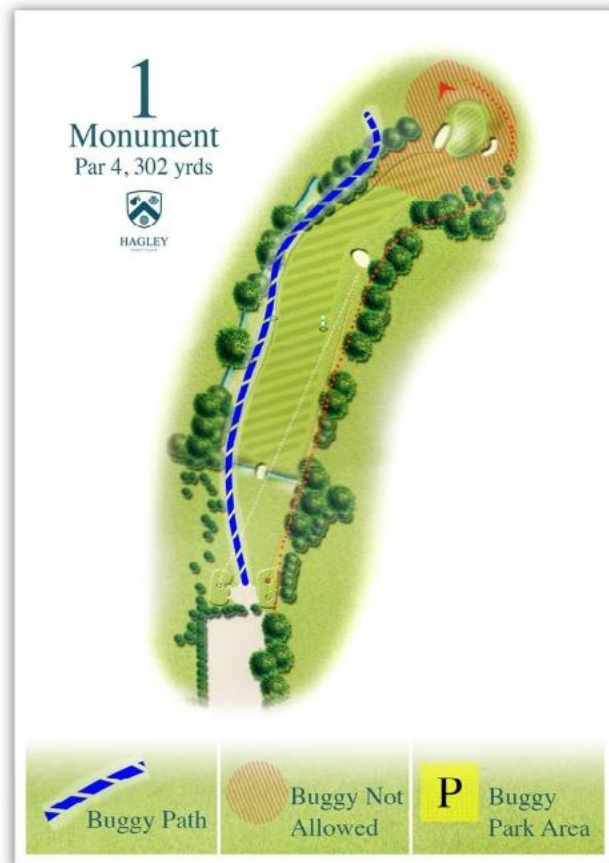
In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies, and electric trollies, to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

In these circumstances holes 10-18 may be opened with restrictions such as a request to carry-only and buggies will not be permitted for health and safety reasons. In these circumstances a further course inspection will be carried out at least once during the day to assess the playing conditions of holes 1-9 and therefore opportunity to use a buggy if required by a golfer who is registered disabled.

Decisions on course conditions are taken by greenkeepers, or other authorised Hagley GC staff, at daily course inspections and reviewed during the day if necessary.

Hole 2

From the WHITE tee, there is a slight slope which forms part of the fairway, please be care full if and when walking down this as it may become slippery due to inclement weather.

From the tee's, there is a buggy path that leads to the left of the fairway.

From the tee's, there are ditches to the left and to the right. There is one on the left-hand side which is in front of the YELLOW & RED tees and this runs into the ditch that comes into play comes into play First Hole tee. Players should therefore shout "FORE", to warn players on the first hole, if their tee shot is seemingly going in that direction. There are 2 crossing points to reach the 1st fairway. When crossing these, please make sure that you cross them with care and attention.

A water hazard lies to the right of the fairway. Please approach with care if your ball lands near it. A **DEEP WATER** sign and a **LIFEBOUY** are visible.

A woodland ditch lies to the bottom left of the fairway.

A ditch runs around the right hand side of the fairway approaching the green and continues going around the back of the green.

A ditch on the left hand side may come into play when approaching the green, this ditch may also come into play from players teeing off on the 9th tee, please be vigilant when playing a shot from this area.

A bunker lies to the left of the green.

A rake is placed in the bunker. Players should place the rake back on its holder with the spikes in the sand.

Golf Balls from all ditches & ponds should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather, the hole is tree lined on both sides, and players should be wary of leaves, branches, that could blow and fall across the fairway and green.

Players should wear appropriate footwear as ground could be slippery in wet weather.

Buggy advice for 2nd hole (including access for registered disabled)

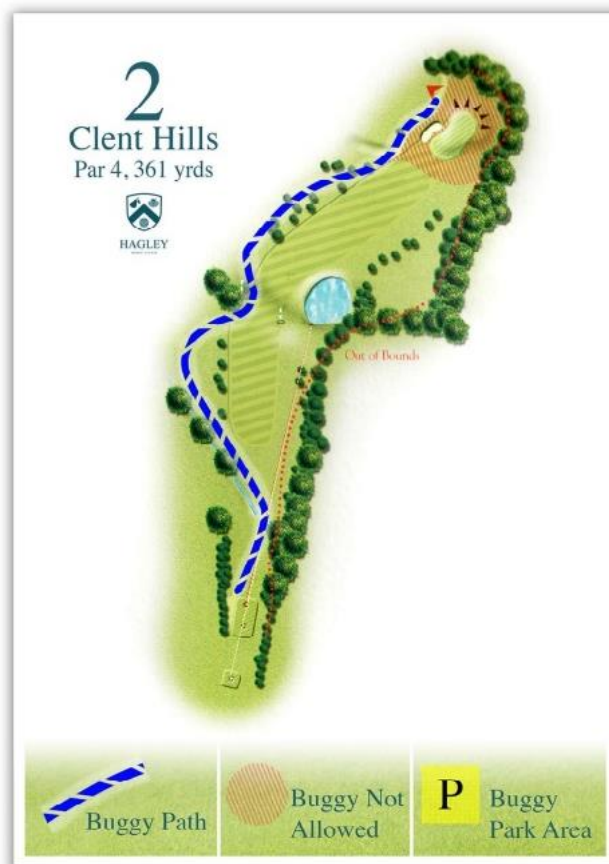
In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

In these circumstances holes 10-18 may be opened with restrictions such as a request to carry-only and buggies will not be permitted for health and safety reasons. In these circumstances a further course inspection will be carried out at least once during the day to assess the playing conditions of holes 1-9 and therefore opportunity to use a buggy if required by a golfer who is registered disabled.

Decisions on course conditions are taken by greenkeepers, or other authorised Hagley GC staff, at daily course inspections and reviewed during the day if necessary.

Hole 3

Walking to this tee, there is a sign stating that players must wait before crossing in front of other players teeing off the Ninth tee, unless instructed to do so.

From the tee's, there is a buggy path that leads to the 4th tee.

From the tee's, there is a ditch which crosses the course from right to left. To cross the ditch, follow the path which goes around it.

From the tee's, the 9th fairway, the 8th green and the 4th tees may also come into play through a wayward shot; therefore "FORE" should be shouted. There is woodland to the right and behind the green, a ditch runs behind the green.

Golf Balls from all ditches should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

The area short right of the green is marked clearly with signage to warn golfers to take extra caution in wet conditions.

In the case of changing weather, players should be wary of leaves, branches, that could blow and fall across tee, fairway and the green.

A bunker lies to the left and right of the green.

A rake is placed in each of the bunkers. Players should place the rake back on its holder with the spikes in the sand.

Players should wear appropriate footwear as ground could be slippery in wet weather.

Buggy advice for 3rd hole (including access for registered disabled)

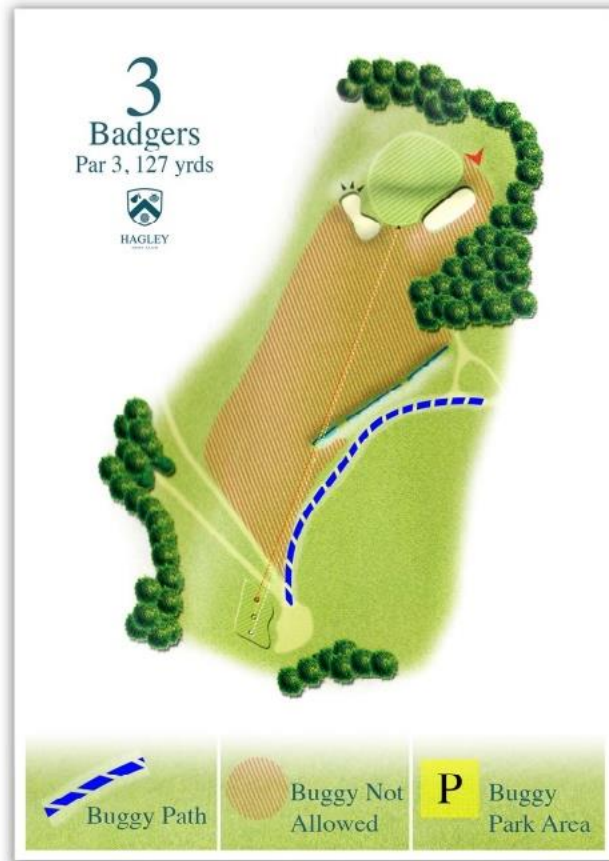
In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

In these circumstances holes 10-18 may be opened with restrictions such as a request to carry-only and buggies will not be permitted for health and safety reasons. In these circumstances a further course inspection will be carried out at least once during the day to assess the playing conditions of holes 1-9 and therefore opportunity to use a buggy if required by a golfer who is registered disabled.

Hole 4

Walking to this tee, the ground is undulating so care must be taken. It can also be approached by a path from the 3rd tee.

There are steps leading up to the tee.

From the tee's, there is a buggy path that leads to the left of the fairway.

From the tee's, there is a ditch which crosses the course from right to left. To cross the ditch, follow the path which goes over it.

From the tee's, there is woodland to the left and right of the fairway, a ditch runs down the right hand side of the fairway, and any miss hit tee shots could endanger players who are playing on the 8th fairway "FORE" should be shouted to make players aware of a miss hit shot.

ELETRIC POWER LINES CROSS THIS FAIRWAY.

The woodland hazard on the left-hand side has a steep slope that leads to water, the RHS also has a steep slope that leads to wet ground.

Leading to the green, a pathway runs from left to right, and players should be wary of internal traffic using this.

A bunker lies to the left and right of the green

A rake is placed in each of the bunkers. Players should place the rake back on its holder with the spikes in the sand. A ditch runs down the left hand side of the green. There is a crossing point from the side of the green to a pathway.

Golf Balls from all ditches should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather, the hole is tree lined from the left had side of the tee, both sides of the fairway and behind the green.

Players should be wary of leaves, branches, that could blow and fall across tee and the hole.

Players should wear appropriate footwear as ground could be slippery in wet weather.

Buggy advice for 3rd hole (including access for registered disabled)

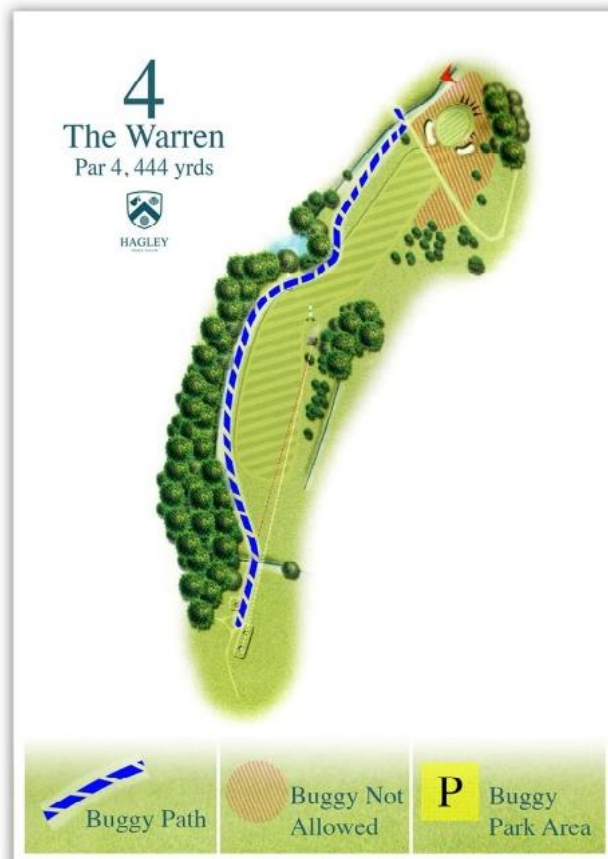
In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

Hole 5

From the tee's, there are woodland hazards to the left and right of the fairway. In both woodlands there are water ditches and both are reached by walking down a hazardous slope.

Due to undulating ground conditions on the fairway and pathway extra care should be taken when walking on either the fairway or pathway.

From the tee's, there is a buggy path that leads to the right of the fairway.

Once a tee shot has been taken. Should the ball start going left "FORE" should be shouted to warn players on the 18th tees. Should the ball go to the right "FORE" should be shouted to warn players on the 7th fairway.

To the right of the fairway a path for vehicles is laid out.

When an approaching shot to the green is over hit "FORE" should be shouted to warn players teeing off on the 6th tee.

A bunker lies to the right of the green.

A rake is placed in the bunker. Players should place the rake back on its holder with the spikes in the sand.

Golf Balls from all ditches should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather, the hole is tree lined from the left and right hand side of the fairway and behind the green.

Players should be wary of leaves, branches, that could blow and fall across tee and the hole.

Players should wear appropriate footwear as ground could be slippery in wet weather.

A player who plays from the left of the green and takes a trolley with them, and needs to walk to the tee for Hole 6, may walk around the back of the green, but will have to be aware that a player may be taking a tee shot on Hole 17.

Should the player take the tee shot and someone is walking behind the green, "FORE" should be shouted.

In this situation it would be ideal for the player from the 5th green to wait for the player on tee 17 to take their shot unless otherwise instructed to go forward.

PLEASE RING THE BELL ONCE YOU HAVE FINISHED THE HOLE SO THAT PLAYERS WAITING KNOW IT IS SAFE TO TEE OFF.

Buggy advice for 5th hole (including access for registered disabled)

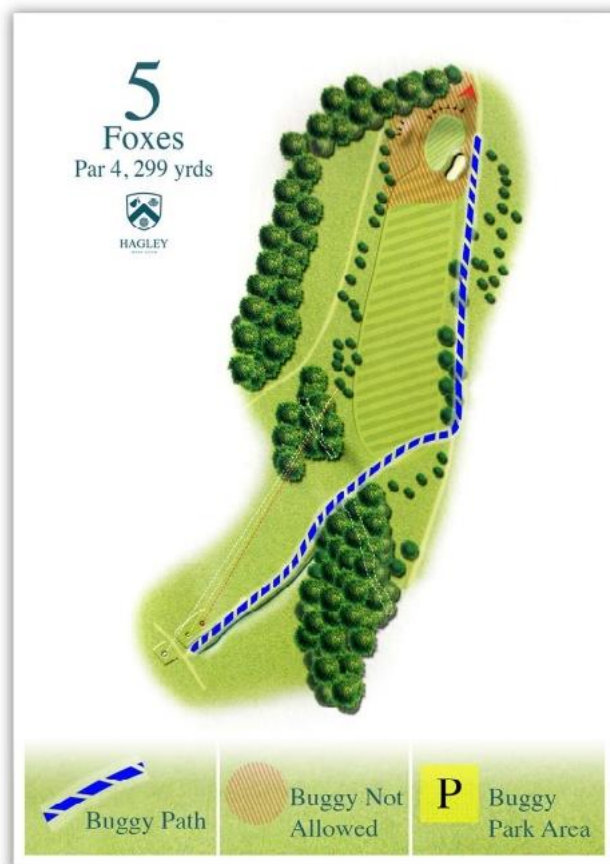
In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

Hole 6

From the tee's, there are woodland hazards around the tee and to the left and right of the fairway.

Walking from the tee to the green the ground is undulating so extra care should be taken.

GC staff, at daily course inspections and reviewed during the day if necessary.

Once a tee shot has been taken, should the ball start going left "FORE" should be shouted to warn players on the 16th fairway & tee's, a ditch runs down the side of the fairway. There is a crossing point to reach this fairway. Players using this should do so with care and attention

When an approach shot to the green is over hit, the ball will land in the ditch or woodland behind.

A bunker lies to the left and right of the green.

A rake is placed in each of the bunkers. Players should place the rake back on its holder with the spikes in the sand.

Golf Balls from all ditches should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather, players should be wary of leaves, branches, that could blow and fall across tee, fairway and green.

Players should wear appropriate footwear as ground could be slippery in wet weather

Buggy advice for 6th hole (including access for registered disabled)

In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

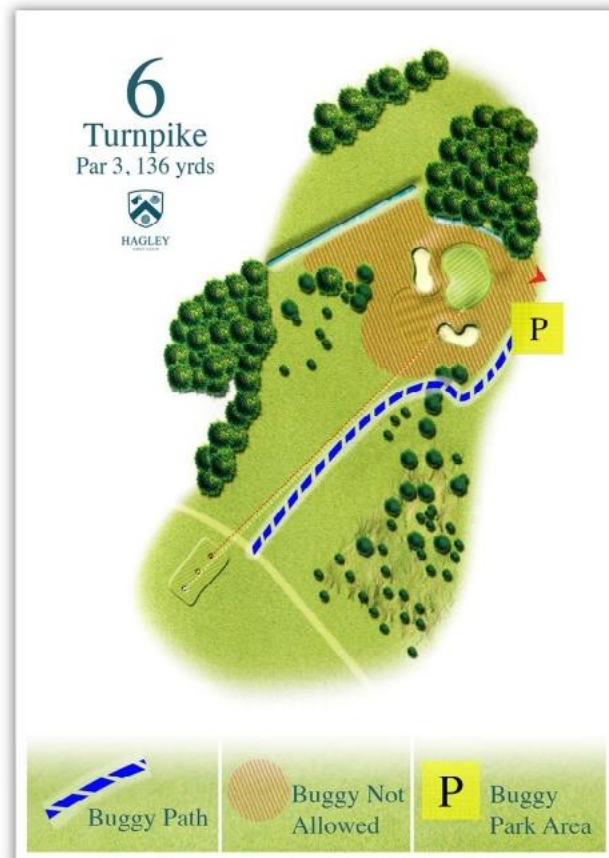
When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

Hole 7

From the tee's, there are woodland hazards around the tee and to the left of the fairway. There is also a large tree on the fairway. Once a tee shot has been taken, should the ball start going left, there is a ditch runs down the side of the fairway which also has planted trees which may come into play. Should the ball be miss hit to the right "FORE" should be shouted as it could impede players on the 5th fairway & green.

There are 4 crossing points from the fairway that access the land on the other side of the ditch. There is also a crossing for buggies. Please be careful when crossing the ditch.

To the right a path for vehicles is laid out.

A woodland area to the right of the green.

A bunker lies to the left and right of the green.

A rake is placed in each of the bunkers. Players should place the rake back on its holder with the spikes in the sand.

Golf Balls from all ditches should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather, players should be wary of leaves, branches, that could blow and fall across tee, fairway and the green.

Players should wear appropriate footwear as ground could be slippery in wet weather

Buggy advice for 7th hole (including access for registered disabled)

In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

Hole 8

From the tee's, there are woodland hazards around the tee and to the left of the fairway. A tree is to the right of the tee(s) and this could come into play should a tee shot be miss hit."FORE" should be shouted as the ball could endanger players on the 7th green.

Once a tee shot has been taken, should the ball start going left, there is a ditch runs down the side of the fairway and also planted trees which may come into play. Should the ball be miss hit to the right "FORE" should be shouted as it may impede players on the 4th fairway.

A path for vehicles crosses the course which is laid out and runs from left to right.

A water hazard is directly in the centre and to the right of the fairway. A **DEEP WATER** sign and a **LIFEBOUY** are visible. Follow the path around the hazard, keeping to the centre.

There are ditches to the left & right. The one on the right side may come into play for the 4th fairway, "FORE" should be shouted if your ball seems to be heading in that direction.

ELETRIC POWER LINES CROSS THIS FAIRWAY.

A ditch in the centre of the fairway runs from left to right a tree could also come into play at this point. "FORE" is to be shouted as not to endanger players on the 4th tee and fairway.

A bunker lies to the left of the green.

If your approach shot is long "FORE" is to be shouted as not to endanger players waiting to play tee's 3 & 9.

A rake is placed in the bunker. Players should place the rake back on its holder with the spikes in the sand.

Golf Balls from all ditches & water should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather, the hole is tree lined from the left hand side of the fairway.

3 new crossing points have been created on the left hand side of the green laid down with bark, please be careful when crossing the ditch whether in a buggy, pushing a golf trolley or using a motorised (battery operated) one.

Players should be wary of leaves, branches, that could blow and fall across tee, fairway and the green.

Players should wear appropriate footwear as ground could be slippery in wet weather.

Buggy advice for 8th hole (including access for registered disabled)

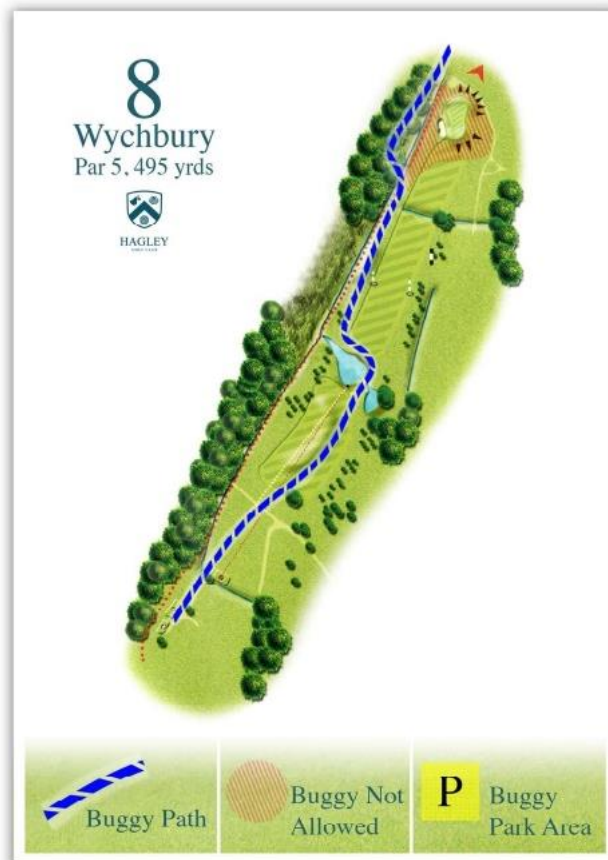
In wet conditions, where it has been assessed that the topography makes the use of buggies potentially hazardous, golfers using buggies must keep buggies on routes described in their 'Buggy Route Planner' and walk 90 degrees to find and play their ball.

When course conditions allow those golfers registered disabled will be permitted to access holes 1-9 on route planner, or in very wet conditions this may be limited to holes 1-5 on paths only, as a safe route from hole 8 to 9 on paths may not be available.

In extremely wet conditions the topography of holes 10-18 are such that they may be deemed unsafe for buggies to access. Due to the propensity of holes 1-9 to retain more standing water than holes 10-18 in extremely wet conditions holes 1-9 may be deemed unplayable by greenkeepers.

Hole 9

From the tee's, there are woodland hazards around the tee and to the left of the fairway.

A sign stating that players must wait until the 9rd green is clear before they make their approach shot is placed on the tee. This must not be ignored.

Players on the tee should be vigilant, as there may be players waiting to cross at the bottom of the bank who are walking from the 2nd green.

From the tee's, there is a buggy path that leads to the left of the fairway.

Once a tee shot has been taken, should the ball start going left "FORE" should be shouted as not to endanger players waiting to walk to the tee, or players on the 2nd fairway, "FORE" should also be shouted if a miss hit tee shot goes to the right as this could put players in danger on the 3rd fairway & green.

There is a ditch and planted trees to the left runs between the this fairway and the 2nd fairway.

There is a wet woodland area to the bottom left of the fairway, which has steep sides.

A woodland on the right of the fairway may come into play, and this can be wet at times.

A ditch to the right of centre comes into play when an approach shot is played to the green. This ditch is also a water hazard and has steep sides.

A bunker lies to the left and right of the green.

If your approach shot is long or miss hit "FORE" is to be shouted as not to endanger players on the 1st tee and players who are practising on the putting green.

A rake is placed in each of the bunkers. Players should place the rake back on its holder with the spikes in the sand.

Golf Balls from all ditches should only be retrieved by using an extended ball retriever, as all ditches have steep sides.

In the case of changing weather players should be wary of leaves, branches, that could blow and fall across tee, fairway and the green.

Players should wear appropriate footwear as ground could be slippery in wet weather.

Buggy advice for 9th hole (including access for registered disabled)

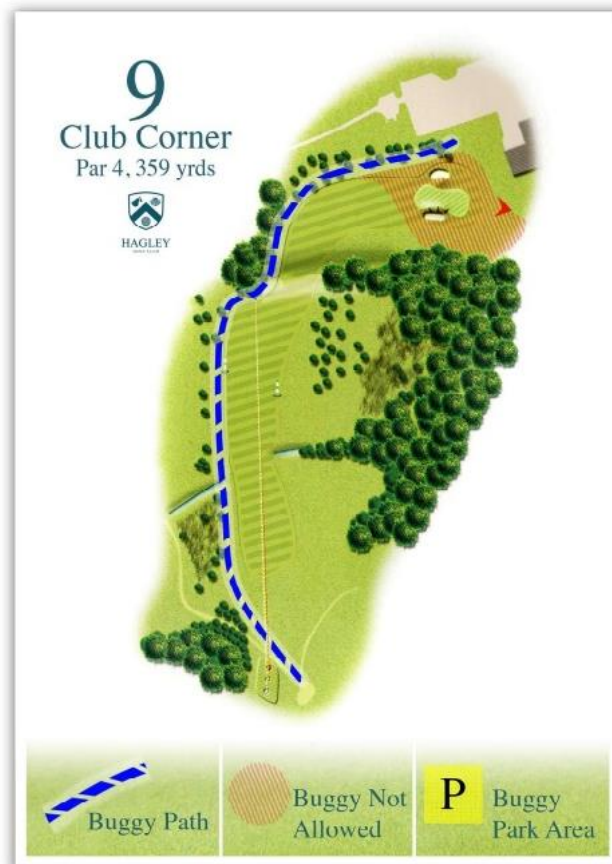

Hole 10

From the tee's, there are woodland hazards around the tee and to the left and right of the fairway.

From the tee's, there is a buggy path that leads to the left of the fairway.

In the case of changing weather, players should be wary of leaves, branches, that could blow and fall across tee and the green.

Players should wear appropriate footwear as ground could be slippery in wet weather.
